## **Instructions for filling out this consignment form**

### ***Address Information:***

- The contact person should be the same person who will be responsible for communications with the duty laboratory regarding the safe arrival of the consignment and to whom results will be reported.
- The information must be typed and the address must be written exactly as it is to be used.
- For phone and Fax numbers, please determine your country code and city or region codes and indicate these on the consignment form.
- Please provide an email address for rapid and reliable communication regarding your shipment.

### ***Shipping Information:***

- To ensure trouble-free shipping, provide very specific, typed destination information. If you nominate a post office box address, please check that your nominated courier will deliver to that address.
- Please check that your nominated courier actually operates in the country of the duty laboratory
- Please check that the courier you nominate delivers directly from the duty laboratory to your destination, without employing a third-party carrier. If a direct delivery is not possible, check if import permits and health certificates are required for countries en-route to your destination.
- If the shipment is international, please ensure that an international account number is supplied

### ***Permit Information:***

- It is the responsibility of the importer to determine if import permits or health certificates are a requirement for import into their country.
- If an import permit must accompany the samples, attach the permit to this consignment form before mailing or fax/email a copy with the consignment form.
- If a health certificate must accompany the samples, attach a model of your country's required certificate to this consignment form before mailing or fax/email a copy with the consignment form. The model should explicitly state which diseases must be tested.
